## CONTRACT SPECIFICATION

### 6. Nature of contract

Fee-based

### 7. Contract description

The purpose of this Technical Assistance contract is to ensure efficient and effective Operational Programme management, and develop the institutional capacity for managing and absorbing IPA funding in accordance with the Framework/Financing/Implementing/Operational Agreements, EU rules, regulations and procedures and applicable national legislation. TA is extended to the Operating Structure regarding horizontal OP management issues, and will support and consolidate the systems, processes and skills for EU funds management and for the absorption of funding under similar OPs in the future.

## **CONDITIONS OF PARTICIPATION**

### **11. Eligibility**

Participation is open to all legal persons participating either individually or in a grouping (consortium) of candidates which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see also item 30 below). Participation is also open to international organisations. The participation of natural persons is governed by the specific instruments applicable to the programme under which the contract is financed.

### **12. Candidature**

All eligible natural and legal persons (as per item 11 above) or groupings of such persons (consortia) may apply.

A consortium may be a permanent, legally-established grouping or a grouping which has been constituted informally for a specific tender procedure. All members of a consortium (ie, the leader and all other members) are jointly and severally liable to the Contracting Authority.

The participation of an ineligible natural or legal person (as per item 11) will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

### **13. Number of applications**

No more than one application can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as leader or member of a consortium submitting an application). In the event that a natural or legal person submits more than one application, all applications in which that person has participated will be excluded.

### **14. Shortlist alliances prohibited**

Any tenders received from tenderers comprising firms other than those mentioned in the short-listed application forms will be excluded from this restricted tender procedure. Short-listed candidates may not form alliances or subcontract to each other for the contract in question.

### **15. Grounds for exclusion**

As part of the application form, candidates must submit a signed declaration, included in the standard application form, to the effect that they are not in any of the exclusion situations listed in Section 2.3.3 of the Practical Guide to contract procedures for EC external actions

### **16. Sub-contracting**

Sub-contracting is allowed up to 5 % of the contract value.

### **17. Number of candidates to be short-listed**

On the basis of the applications received, between 4-8 candidates will be invited to submit detailed tenders for this contract. If the number of eligible candidates meeting the selection criteria is less than the minimum of 4, the Contracting Authority may invite the candidates who satisfy the criteria to submit a tender.

## SELECTION AND AWARD CRITERIA

### 21. Selection criteria

The following selection criteria will be applied to candidates. In the case of applications submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

- 1) Economic and financial capacity of candidate (based on item 3 of the application form). In case of applicant being a public body, equivalent information should be provided.

Legal persons:

- (a) the annual turnover of the candidate for the years 2007 and 2008<sup>1</sup> must be equal to or exceed EUR 780.000
- (b) the cash and cash equivalents of the candidate at the end of the years 2007 and 2008 are positive

- 2) Professional capacity of candidate (based on items 4 and 5 of the application form)

Legal persons:

- (a) at least 4 staff currently work for the candidate in field related to the management of EU funds (financial management and control, monitoring of EU funded projects, grant scheme, service, supply and works procedures)

- 3) Technical capacity of candidate (based on items 5 and 6 of the application form)

Legal persons:

The candidate has worked successfully on at least one technical assistance project covering the field of management of EU funds (financial management and control, monitoring of EU funded projects, grant scheme, service, supply and works procedures) and field of information and publicity management. These fields can be covered by one single project or by separate projects.

The project(s) must have been:

- (a) completed in 2006, 2007, 2008 or 2009<sup>2</sup>
- (b) implemented in a country eligible under Phare programme<sup>3</sup>
- (c) with a budget (own contribution) equal to or exceeding EUR 1.700.000

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the Contracting Authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality, as the economic operator.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be reexamined to identify the eight best applications for the tender procedure. The only factors which will be taken into consideration during this re-examination are:

- 1) The total number of projects managed by the candidate according to criterion 3.
- 2) In case of competition between two or more candidates having the same number of eligible projects, the candidates will be ranked in descending order according to the total amount of their own contribution to the eligible projects
