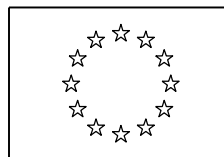


Local publication for call for proposals

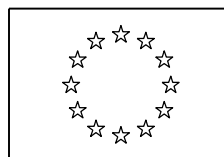
Central Finance and Contracting Agency of the Republic of Croatia is seeking proposals for projects that would strengthen the capacities of the civil society organizations and their partner's organizations to act both as proactive policy advocates and watchdogs in important areas of EU accession such as democratisation and human rights (age, health status, ethnic origin, sex, sexual orientation, social or economic status, gender, etc.), refugee return and integration of Serb minority, particularly on the regional level in Croatia with financial assistance from the *Instrument for Pre-Accession Assistance (IPA), National Programme for Croatia under the IPA – Transition Assistance and Institution Building Component for 2009 (under Civil Society Facility)*.
